INFORMATION ITEMS IN PACKET

GO Virginia Region 6 Budget Update

Mr. Beale noted that the recent project status update was included in the packet and directed Mr. Ginger to discuss the use of \$100,000 in the GO Virginia Region 6 budget, and ideas on how to use that money as part of the GO Virginia Region 6 Budget Update. The Council discussed the potential of a regional meeting/conference in the first quarter of 2023 to bring together businesses, localities, and organizations to come up with project ideas for Region 6.

Mr. Ginger then discussed the ULI/Region Development Summit. The ULI summit would be announced in the next Newsletter to have people submit ideas for discussion that would then be voted on in Executive Committee.

Project Status Update

Mr. Ginger noted that the Project Status Update was included in the Packet, and went over the project updates. Council discussed potential collaboration between Careers in Aquaculture and the oyster test bed at Hull Springs.

Mr. Ginger gave an update on potential projects in the pipeline.

DHCD Budget Update

Mr. Beale then introduced Ms. Weidhaas and Mr. Gammel to discuss the DHCD Budget. Council discussed the recapture of GO Virginia funds and change in budget.
